The consolidated financial statements for the fiscal year ended July 31, 2021, together with the Independent Auditors' report, will be presented for review.

This process, known as “notice-and-access”, directly benefits the company through a substantial reduction in both postage and material costs and also helps the environment through a decrease in paper documents that are ultimately discarded.
